8. ELECTRICITY

Each classroom laboratory has been electrically engineered with wall outlets and other supplementary electrical capabilities.

All of the classrooms utilize the standard Type B plugs (NEMA5-15U.s. 3pin) rated 125V AC standardized by IEC as IEC 60906-2



9 - 9.1: INTERNET ACCESS

All classrooms have Internet access capabilities.

Teachers have the option of accessing the Internet either by connecting to the Department of Education's Ethernet or wireless network.



10. PHYSICAL SET-UP

IT equipment must be kept in a cool, dry, environment. As a result, our computer labs are outfitted with air-conditioning units.

Moreover, IT equipment are stationed on wooden cubbies, along with other peripheral devices.



10. 1 : SECURITY MEASURES

In order to provide adequate security to our computer specified rooms, a few safety measures were added.

First, we placed bars on the doors and windows. Second, the locks and doorknobs were replaced. And thirdly, only the individuals who are granted access to the rooms are designated as responsible key holders by the Administration.



10.2 : ADDITIONAL SECURITY

Documentation provides for proper handling of the IT equipment, therefore, teachers who need access to the computer rooms will be asked to sign-in each time they use the facility.

After the proper sign-in requirements have been justified, then the teachers will be given the key to utilize the lab as needed.
